There is no setup on Friday evening, so help will be needed to unload and set up the equipment at 6:30 a.m. on Saturday morning. Only those helping with this set up will be allowed to set their floor covering down before the building is open to all at 7:00 a.m. There are two entrances, one in the front and one on the side closest to the lower parking lot. The building will open at 6:30 a.m. on Sunday. FISC requires waterproof matting (this is a MUST) be used under your crates. Water ONLY in the crating area, please. ONLY high occupancy x-pens are allowed. Please DO NOT crate reactive dogs in high traffic areas or you will be asked to move.

WAIT LIST I still have a few dogs on the wait list for Saturday only. If you find you need to pull out of the trial, please let me know by Monday, September 13th at 6pm and you will get a full refund for Saturday only.

MEASURING

Our judge is a VMO. ALL dogs without a valid Jump Height Card must be measured prior to running. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

MOVE-UPS The deadline for move ups for the first day your dog is entered is 6 p.m. Monday, September 13, 2021. Day to day move-ups must be received on site within 15 minutes after the last class.

FOOD

DIRECTIONS

From Route 70, merge onto US-40 toward US-15 N/Gettysburg (US-40 becomes US-15 N). Merge onto MD-26 E/Liberty Rd. via Exit 17 toward MD-194/Libertytown/Walkersville. Take the 1st right onto Routzahns Way/MD-355. Take 1st right onto Wormans Mill Ct. Take the 1st left onto Brookfield Ct. FISC is on the right. WALK THROUGH SCHEDULE (small to tall both days)

Exc/Master classes will be split as follows: 4/8/12/16 split into 2 walks then run; 20/24/24C walk then run.

All other classes will have all heights walk together.

The Club has no responsibility for providing service through a public address system or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
